The total base rate charges for the current billing period shall include all base rate schedule charges, discounts, surcharges or other adjustments, excluding the Energy Cost Adjustment, Residential DSM Adjustment, Commercial and Industrial DSM Adjustment, SolarSaver Adjustment, IRP Cost Recovery Adjustment, Firm Capacity Surcharge.
